With reference to the above cited subject, as per ref (1) Conditional Fire Safety Recommendation report was issued by the District Fire Officer, Hulimavu Fire Station to the educational premises of M/s Chrysalis High Bannerghatta, #36-37 SH87, Gollahalli, Bannerghatta Road, Bangalore-560 083 with a condition to fulfill the recommendation and compliance the same within 03 months.

With reference cited ref (2) above the management M/s Chrysalis High Bannerghatta,, had requested for the fire safety compliance report from our department. In this regard the above addressed educational building was re-inspected by Fire Station Officer, Hulimavu Fire Station on 05-06-2025 for issue of fire safety compliance report. And as per ref (3) submitted the report to issue of fire safety compliance report.

Under the above circumstance the Karnataka Fire & Emergency Services Department is issuing the "Fire Safety Compliance Report" to the educational premises of M/s Chrysalis High Bannerghatta, #36-37 SH87, Gollahalli, Bannerghatta Road, Bangalore-560 083. Subjected to proper maintenance of fire-fighting installations in the good working conditions and must arrange for 40% of staff/employees training in fire prevention and fire fighting at R.A.Mundkur fire and emergency services academy within the 03 months from date of issue of this certificate.

In case the Fire prevention and Fire fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of Chemicals, Solvents, Petroleum products (Diesel/Petrol), LPG, etc in the premises/building. This fire safety compliance is issued from the fire prevention and fire fighting point of view, The Karnataka State Fire and Emergency Services Department is not responsible for the ownership of the land, its location and other disputes, which may arise in due course
